- **2.** Appointment will be on direct selection or on standard deputation terms and conditions as issued by DOPT from time to time.
- **3.** Upper age limit is indicated as on the last date for receipt of application i.e., March 31, 2011 and is relaxable for SC/ST (5-years)/OBC (3-years)/PH/Ex-servicemen and certain other categories as per GOI instructions.
