## **Proposed Applications:**

- Analysis of trace metals in plant tissues/plant products, for qualitative, quantitative and Isotope ratio measurement.
- Bio-Imaging.

## **Minimum Specifications:**

#### **Laser Ablation**

- Higher absorption rate at 213nm for ablation of all materials including fragile and easily cleaved minerals
- Long, spike-free, stable signals
- Beam delivery system should be capable for uniform craters with energy densities that remain constant when changing spot sizes
- Precision depth profiling and spot sizes to <10μm
- Compability to accommodate large format and specialized sample chambers including LN2 chambers
- Fully automated laser ablation software, including sample mosaic navigation function. For Windows 95, 98, NT, 2000.
- Wavelength and feature upgradability
- LA System should be provided with software for imaging application which use ICPMS data to give information on 3D topography of element composition in different layer of seeds, leaf etc.
- Vendor should have established facility for LA-ICP-MS, data analysis and imaging at reputed institute for this application and the reference should be given along with documents.
- Best ICP-MS compatibility with LA will be preferable.

#### **ICP-MS**

- The system should be totally software controlled. The system should be GLP/GMP, CFR 21 part 11 compliance.
- -The system should be capable of interfacing with HPLC and GC of the same firm or different (should be specified). It should be possible to use the system in standard, collision cell and reaction modes. The system should be equipped with diagnostic software. The bidder must provide SP, OP and QP.
- ICP-MS system, fully automated, computer controlled with auto-sampler and auto-dilution facility to deliver highest signal to noise ratio for the measurement of trace elements. The application involves plant samples (seed, leaf, root, stem, flower, fruit etc.), environmental samples like water, sludge and soil digests, composts, etc. Sensitivity pertaining to each element to be quoted with different matrices.
- Qualitative and quantitative, trace and ultra-trace element analysis (from ppt levels to high ppm levels) of biological samples in a preferably higher range and with higher sensitivity. Detection level should be less than 100 ppt or preferably lower.
- Collision & Reaction Cell Technology in a single system
- Measurement techniques for qualitative, quantitative and isotopic ratio measurement of analytes.
- -- Choice to use the system in standard mode, collision cell mode & reaction mode
- Preferably higher mass Resolution
- Preferably lesser maintenance
- Minimum background rate
- Features for making the instrument high sample sensitivity and high resolution (should be specified)

#### - SAMPLE INTRODUCTION SYSTEM

- Open architecture sample introduction system with the nebuliser and spray chamber mounted externally to the torch base. It should be suitable for use with aqueous, organic and HF resistant spray chamber, so any liquid sample including corrosive matrices can be run without risking damage to the system
- A-quartz ICP torch should be demountable, rugged and easy to maintain.
- It shall be possible to isolate the ICP torch from the load coil screen, for normal, cool plasma and hot screen modes of operation. The screen should be fixed in position and encapsulated to give enhanced component lifetime.
- Operation in hot screen mode must provide x3-x5 increase in sensitivity for mid-high mass elements without affecting the mean background count rate.
- The sample Introduction system should have very low dead volume, minimum waste generation.
- ICP torch position adjustable in x, y, z planes under computer control

#### -ICP-MS INTERFACE

- The system should have facility to remove polyatomic & Isobaric Interferences
- The sampling and skimmer cones should provide high transmission and minimize condensation of sample matrix in the cone orifice or preferably better
- The standard high performance interface should be designed to minimize mass bias and provide high sensitivity and uniform mass response across the mass range.
- A guaranteed sensitivity for ln >60 mcps/ppm, co>30 mcps/ppm, u>45 mcps/ppm, y>60mcps/ppm and pl>45mcps/ppm or preferably better within a single analytical acquisition.

#### - ION FOCUSING SYSTEM AND MASS ANALYSER

- The ion guide, mass analyzer and detector should have easy user access to all components or preferably better.
- The analyzer chamber shall be cable free in order to provide complete freedom from wire cable connections giving increased reliability and to reduce stray RF leakage to zero.
- The mean background count rate of the system must be guaranteed to be <1 cps at 220 amu or preferably better.
- The instrument should be able to reduce argon and other molecular /polyatomic background species. The sensitivity and background specifications shall be unchanged.
- A high-performance quadrupole mass analyzer to be provided with RF generator at a higher MHZ and aligned to the ICP torch and ion lens for minimum instrumental background. The mass range of the analyzer shall be 2 to 250 amu or preferably better.

### - VACUUM SYSTEM

- The spectrometer shall include an integral 3-stage differentially pumped vacuum system. A single split flow turbo pump, will evacuate the ion lens and analyzer regions backed by a single rotary vane pump that also evacuates the interface region. It shall be possible to site the rotary pump remotely for reduced noise and atmospheric contamination.
- The capacity of the pumping system shall provide a final operating vacuum in the analyzer region ensuring a high quality mass spectrum with good peak shapes and excellent abundances sensitivity.
- The capacity of the pumping system shall enable the use of gases like NH3, Helium, Hydrogen, etc in order to maximize instrument reliability and operator safely.
- Vaccume system capable to reach operating vacuum from atmosphere in less than 30 minutes or preferably

#### - INSTRUMENT CONTROL AND DATA ACQUISITION

- The spectrometer will incorporate an embedded PC with a custom design PCI card for data acquisitions and instrument control.
- Software diagnostics shall be provided to enable the electronic error file to interrogate locally or remotely via a modem link.
- Provision of prevention of clogging and minimization of signal drift
- Computer controlled, all solid state 40 or 27.1 MHz ICP-MS source (literature support for the claim of better source) with output power 500-1600 watts
- Computer controlled Mass Flow Controllers for the nebulizer, coolant and auxiliary Argon gas lines
- Quadrupole Assembly with preferably best stability and resolution

#### - SOFTWARE

- Full remote diagnostics software to be included in the standard software package to allow interrogation of the system by trained service personnel without the need for site visit.
- The instrument system software shall be based on Windows XP operating system.
- Intelligent instrument sliders with guides for tuning the instrument for different analytical conditions with digital read back of the tuning parameters.
- Auto tuning to enable the instrument to be used with consistent and reproducible day-to-day performance, independent of the operator. The software must be capable of running performance reports prior to acquiring data and generating electronic and hard copies of these reports.
- All tuning parameters including plasma position to be stored on disk or in a tune file that can be recalled at any time.
- Auto tuning the software for mattered operation.
- Matrix specific databases to provide preferred isotope selection following user entry or measurement of matrix elements, databases will also include interface correction equations.

1. <u>GENERAL:</u> Quotations in closed cover are invited on behalf of the Executive Director, National Agri-Food Biotechnology Institute, Mohali from the reputed Indian and foreign manufacturer. <u>The offer/ quotation must be</u> strictly as per required specifications and the tender terms & conditions.

#### 2. PREPARATION AND SUBMISSION OF OFFERS:

- **a.** Quotation should be submitted directly by the original manufacturer/supplier or its sole authorized distributor/dealer. In case of bid by authorized dealer/distributor, the manufacturer authorization should be attached with the technical bid as per **Annexure-'G'**.
- **b.** In case a bidder is not doing business within India, it shall furnish the certificate to the effect that the bidder is or will be represented by an agent in India equipped and able to carry out the supply, maintenance, repair obligations etc. during the warranty and post-warranty period or ensure a mechanism at place for carrying out the supply, maintenance, repair obligations etc. during the warranty and post-warranty period.

#### **4.** EARNEST MONEY DEPOSIT (EMD):

- a. EMD in the form of Bank guarantee (As per format enclosed as ANNEXURE- 'C') or Term Deposit Receipt/FDR or Bank Draft of a scheduled bank pledged in the name of NATIONAL AGRI-FOOD BIOTECHNOLOGY INSTITUTE, MOHALI valid for 180 days from the date of opening of the tender for the required amount as mentioned in the tender notice separate for each item must be submitted along with the quotation (with the technocommercial quotation in case of two-bid system and photocopy of the same enclosed with the price bid and for foreign manufacturers they should furnish the EMD in foreign currency equivalent to Indian rupees, otherwise quotation may not be considered. The firm registered with DGS&D/NSIC as manufacturer for the supply of the same category of item for which the party is submitting quotation will be exempted from submission of EMD. No changes in prices will be acceptable in any condition after opening of tender till the validity of the offer or execution of the order whichever is later.

- 7. **EVALUATION OF BIDS:** Before submission of bid, the bidder is expected to examine all the instructions, forms, terms and specifications in the bidding document and should ensure that the following conditions are fulfilled:
  - a. Bidder Information form as per Annexure-'I'.
  - **b.** The price schedule should be enclosed and must be signed.
  - **c.** The bid validity should not be shorter than required.
  - **d.** The manufacturer's authorization should be enclosed in case the bidder is authorized dealer/ distributor.
  - **e.** The bidders should agree to provide the Performance Security.
  - **f.** The quoted goods should be as per required specifications.
  - g. In case the bid is substantially responsive, the purchase may request that bidder may submit the necessary information, documentations, within a reasonable period of time, to rectify, non-material, non-conformities or omission in the bid related to documentation requirements. Failure of the bidders to comply with the request may result in the rejection of its bids. - c. Copies of at least last three supply orders of the last 3 years received from other customers along with details of such supply orders preferably in India for the same item/model may be submitted with the offer giving reasons of price difference of their supply order & those quoted to us, if any. (As per Annexure -'H').
- d. The party must give details of identical or similar equipment, if any, supplied to any CSIR lab during last three years along with the final price paid and Performance certificate from them.
- **11.** <u>ANNUAL MAINTENANCE CHARGES:</u> The party <u>must</u> mention in the quotation, the rate/amount of annual maintenance charges, if we opt for maintenance contract after expiry of the warranty period. This is mandatory to mention.

## **12.** SPECIFICATIONS:

- A. Specifications are basic essence of the product. It must be ensured that the offers must be strictly as per our specifications. At the same time it must be kept in mind that merely copying our specifications in the quotation shall not make the parties eligible for consideration of the quotation. A quotation has to be supported with the printed technical leaflet/literature of the quoted model of the item by the quoting party/manufacturer and the specifications mentioned in the quotation must be reflected/supported by the printed technical leaflet/literature. - **B.** The technical bid shall be evaluated for acceptability by the technical committee and may call the tenderers for discussion. If necessary, the committee may modify the technical specification to suit the NABI requirement.

## **13.** COMPLIANCE STATEMENTS:

- a. Bidders must furnish a Compliance Statement of each and every required Specification of our tender in the format at ANNEXURE -'B'. The deviations, if any, from the tendered specifications should be clearly brought out in the statement. Technical literature/leaflet showing the compliance of the specification may also be attached with the quotation.
- b. Similarly, the Compliance Statement/questionnaire for Terms & Conditions of the tender may be furnished, as per the enclosed format at Annexure -'A', along with quotation (with techno- commercial bid in case of two bid tender system).
- **c.** The firms are advised to submit both the compliance statements essentially along with their quotation failing which their offer may not be considered.
- **14.** PERIOD & MODE OF DELIVERY: The delivery period is the essence of supply; hence it must be indicated specifically in the quotation. Mode of delivery, tentative size and weight of consignment may also be indicated in the quotation.
- **PERFORMANCE SECURITY:** All the successful bidders will have to submit the Performance Bank Guarantee or establish a Standby Letter of Credit (SLOC) or a Bankers cheque / or FDR pledged in favour of EXECUTIVE DIRECTOR, NABI for required amount as per payment terms mentioned at clause **16** below except where supplier opts for release of amount equivalent to PBG after expiry of warranty period. The PBG format shall be provided to the successful bidder later on along with the purchase order.

#### **16.** PAYMENT CONDITION:

#### A. FOR INDIGENEOUS SUPPLIES:

**Payment on Bill Basis after supply:** For local supplies the payment will be made only after satisfactory installation, commissioning and performance of the equipment at NATIONAL AGRI-FOOD BIOTECHNOLOGY INSTITUTE, MOHALI and after certification by our technical expert/scientist. However, supplier will be required either to submit performance bank guarantee for 10% amount of the total value of equipment, after installation of the material, valid up to 60 days after the expiry of warranty period or the equivalent amount shall be released after expiry of the satisfactory warranty period.

## B. FOR IMPORTS:

The payment against imports shall be made through irrevocable L/C. <u>L/C</u> will be opened for 100% <u>FOB/CIF</u> value. 90% of L/C amount shall be released on presentation of complete and clear shipping documents and remaining

10% shall be released after installation/demonstration/commissioning, subject to submission of PBG of equivalent amount to cover the warranty period. The PBG should remain valid up to 60 days after the expiry of warranty period. In case of non-submission of PBG after installations/demonstration/commissioning, remaining payment i.e. 10% will be released only after the completion of warranty period.

- 17. <u>COMMENCEMENT OF WARRANTY PERIOD:</u> The warranty period of an item shall commence from the date of receipt of the item in good working condition and satisfactory installation/commissioning/demonstration at the project site in NATIONAL AGRI-FOOD BIOTECHNOLOGY INSTITUTE, MOHALI. The warranty period and validity of Performance Guarantee shall be extended for the period of delay in satisfactory installation and delay in warranty services.
- **18. NO ADVANCE PAYMENT:** No advance payment will be made to any supplier.
- 19. <u>INSTALLATION:</u> The equipment should be installed/commissioned and demonstrated, by the supplier at the lab immediately but in any case within one month after receipt of the item in the lab and the same will be put under operation to the satisfaction of our technical expert/Scientist who will test the performance of the equipment. No separate charges for installation etc. will be paid to the party beyond the quoted prices.
- **20.** GUARANTEE/WARANTY: The equipment/instrument must be guaranteed/warranted for a period of at <u>least</u> one year, if not specifically mentioned otherwise in the specifications sheet, from the date of its satisfactory installation/commissioning against all manufacturing defects. If the equipment is found defective during this period the whole equipment or part thereof will have to be replaced/repaired by the supplier free of cost at the lab. or at site of the supplier for which 'to and fro' expenses will be borne by the supplier. However, if the items are guaranteed for a period of more than one year, it may be specifically mentioned in the quotation.
- **21. SPARE PARTS:** Availability of spare parts of the equipment/instrument must be guaranteed for a period of preferably **ten** years from the date of supply.
- **22. AFTER SALES SERVICES:** It should be clearly mentioned in the quotation whether the after sales services during and after the completion of warranty shall be provided directly by the supplier or their authorized agent/representative. Terms of the after sales services, if any, may be mentioned in the offer. However, in both the cases the original supplier shall be responsible for poor performance/services. The company should have service engineers within 300 km of the range of the institute.

### 23. INSPECTION:

- a. The inspection of the system will be done by our technical expert /Scientist in the presence of firm's representative.
- **b.** In case of receipt of the material in short supply or damaged condition the supplier will have to arrange the supplies/ replacement of goods free of cost pending the settlement of the insurance case wherever applicable on FOR at the lab. or CIF basis till satisfactory installation of the system.
- c. The supplier should arrange for physical Inspection of the items directly or through their authorized representative within seven days of arrival of the consignment failing which they will be responsible for the losses. After the shipment is effected, the supplier/its representative/Indian agents must remain in touch with the lab/instt. to ascertain the date of arrival of consignment.

#### 24. <u>AUTHORIZATION OF INDIAN AGENTS & INDIAN REPRESENTATIVE:</u>

- a. In case there is involvement of an /Indian agent/representative in any form as mentioned at (b) below, an authority letter / copy of agreement from the principal manufacturer must be submitted with the quotation.
- **b.** Where quoting party/Indian representative claims to be the subsidiary or branch office or an authorized representative of the principal foreign manufacturer/supplier in India, then a copy of approval from RBI/Ministry for operating business in India as Subsidiary/Branch/Liaison office or Joint-Venture may be submitted with offer.
- **c.** The details of all supplies involving the foreign exchange shall be furnished to the Enforcement Directorate, Chandigarh as per rule. - b. If you have supplied identical or similar equipment to other CSIR Labs./DBT Insts., the details of such supplies for the preceding three years shall be given together with the prices finally paid.

#### **26.** PENALTY CLAUSE FOR LATE DELIVERY & LATE INSTALLATION:

- a. Subject to operation of Force Majeure, time for delivery and acceptance is the essence of this contract. The supplier shall arrange to ship the ordered materials within the delivery period mentioned in the order unless extended with/without penalty.
- **b.** In case of delay in supply on part of the supplier, a penalty @ 1% per week of Order/FOB value will be charged for delayed period subject to a maximum of 10% of order/FOB value.
- c. If the delay in the shipment of the ordered materials attributable to the supplier exceeds agreed time period from the date of original agreed upon date of shipment and extended with/without penalty, the NATIONAL AGRI-FOOD BIOTECHNOLOGY INSTITUTE shall have the right to cancel the contract/purchase order and recover the liquidated damages from other dues of the party or by legal means. It will also affect the other/future business dealings with such suppliers.
- d. The same rate of penalty shall be applicable for late installation of the equipment/instrument also.
- **TRAINING:** Wherever needed, Our Scientist/Technical persons should be trained by the supplier at the project site free of cost. In case the person is to be trained at supplier's site abroad or in India it should be mentioned in the quotation clearly. The supplier should bear all the expenses for such training including 'to & fro' fares and lodging & boarding charges.
- **28. NON-SUBMISSION OF TENDER:** In case you are unable to submit your quotation against our tender enquiry we would appreciate and expect a note of regret from your side giving in brief, reasons for not quoting.
- **29. <u>DELETION OF NAME</u>**: Names of bidders, backing-out/defaulting after opening of tenders will be recommended for deletion from the list of suppliers in addition to forfeiture of EMD submitted by them, if any.
- **30.** <u>LATE/ DELAYED /UNSOLICITED QUOTATION</u>: Late or delayed/Unsolicited quotations/offers shall not be considered at all. These will be returned to the firms as it is. Post tender revisions/corrections shall also not be considered.
- **31.** <u>ACCEPTANCE OR REJECTION OF OFFER:</u> The Executive Director, NATIONAL AGRI-FOOD BIOTECHNOLOGY INSTITUTE, MOHALI reserves the right to accept or reject any quotation /tender in part or full without assigning any reason thereof. The successful bidder should submit Order acceptance within 15 days from the date of issue.
- **32. PAGE NUMBERING & SIGNATURES:** Your offer should be a page numbered and signed by an authorized signatory giving his/her name and designation below the signatures.
- **33. INTERIM ENQUIRIES:** No interim inquiries will be attended.
- **34. FORCE MAJEURE:** The Supplier shall not be liable for forfeiture of its performance bank guarantee, liquidated damages or termination for default, if and to the extent that, it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure. For purposes of this Clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the Purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

If a Force Majeure situation arises, the Supplier shall promptly notify the Purchaser in writing of such conditions and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its

obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

**35. DISPUTE SETTLEMENT:** All disputes arising out of this contract shall be referred to the sole arbitration of the Executive Director of National Agri-Food Biotechnology Institute, Mohali or his nominee, who is overall controlling authority of this laboratory as per the provisions of Indian Arbitration and Reconciliation Act 1996 and his award shall be final and binding on the parties to the dispute. However, in case of importers, the provisions related to Arbitration as per the United Nations Commission on International Trade Laws (UNCTRAL) will be applicable and binding on both the parties. The venue of arbitration in both the above cases will be Chandigarh (INDIA).

## FORMAT OF THE INTEGRITY PACT

Integrity Pact Between

NATIONAL AGRI-FOOD BIOTECHNOLOGY INSTITUTE (NABI) hereinafter called to as "The Principal" And

#### **Preamble**

In order to achieve these goals, the Principal will appoint an Independent External Monitor (IEM), who will monitor the tender process and the execution of the contract for compliance with the principles mentioned above.

#### Section 1 – Commitments of the Principal

- (1) The Principal commits itself to take all measures necessary to prevent corruption and to observe the following principles:
  - **a.** No employee of the Principal, personally or through family members, will in connection with the tender for , or the execution of a contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitles to.
  - **b.** The Principal will, during the tender process treat all Bidder(s) with equity and reason. The Principal will in particular, before and during the tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential/additional information through which the Bidder(s) confidential/ additional information through which the Bidder(s) could obtain an advantage in relation to the tender process or the contract execution.
  - **c.** The Principal will exclude from the process all known prejudiced persons.
- (2) If the Principal obtains information on the conduct of any of its employees which is a criminal offence under the IPC/PC Act, or if there be a substantive suspicion in this regard, the Principal will inform the chief Vigilance Officer and in addition can initiate disciplinary action.

#### **Section 2 – Commitments of the Bidder(s) / Contractor(s)**

- (1) The Bidder(s) /Contractor(s) commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the tender process and during the contract execution
  - **a.** The Bidder(s)/ Contractor(s) will not, directly or through any other person of form, offer, promise or give to any of the Principal's employees involved in the tender process or the execution of the contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract.
  - **b.** The Bidder(s)/ Contractor(s) will not enter with other Bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
  - c. The Bidder(s)/ Contractor(s) will not commit any offence under the relevant IPC/PC Act; further the Bidder(s)/ Contractor(s) will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or document provided by the Principal as part of the business relationship, regarding plans, technical proposals and business details, including information conta8ined or transmitted electronically.
  - d. The Bidder(s)/ Contractor(s) of foreign origin shall disclose the name and address of the agents/representatives in /India, if any. Similarly the Bidder(s)/ Contractor(s) of Indian Nationality shall furnish the name and address of the foreign principals, if any. Further details as mentioned in the "guidelines on Indian agents of Foreign Suppliers" shall be disclosed by the Bidder(s)/ Contractor(s). Further, as mentioned in the Guidelines all the payments made to the Indian Agent/representative have to be in Indian Rupees only. Copy of the "Guidelines on Indian Agents of Foreign Supplies" is annexed and marked an Annexure.

- e. The Bidder(s)/ Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract.
- (2) The Bidder(s)/ Contractor(s) will not instigate third persons to commit offences outlines above or be an accessory to such offences.

#### Section 3 - Disqualification from tender process and exclusion from future contracts

If the Bidders(s) / Contractor(s), before award or during execution has committed a transgression through a violation of Section2, above or in any other form such as to put his reliability or credibility in question, the Principal is entitled to disqualify the Bidders(s) / Contractor(s), from the tender process or take action as per the procedure mentioned in the "Guidelines on Banning of Business Dealing". Copy of the "Guidelines on Banning of Business Dealing" is annexed and marked as Annex – "B".

#### **Section 4- Compensation for Damages**

- (1) If the Principal has disqualified the Bidder(s) from the tender process prior to the award according to Section 3, the Principal is entitles to demand and recover the damages equivalent to Earnest money Deposit/Bid Security.
- (2) If the Principal has terminated the contract according to Section 3 or if the Principal is entitles to terminate the contract according to Section 3, the Principal shall be entitles to demand and recover from the Contractor liquidated damage of the contract value or the amount equivalent to Performance Bank Guarantee.\

#### <u>Section 5 – Previous transgression</u>

- (1) The Bidder declares that no previous transgressions occurred in the last 3 years with any other company in any country conforming to the anti corruption approach or with any other Public Sector enterprises in India that could justify his exclusion from the tender process.
- (2) If the Bidder makes incorrect statement on this subject, he can be disqualified from the tender process or action can be taken as per procedure mentioned in "Guidelines on Banning of business dealings."

## <u>Section 6 – Equal treatment of all Bidders/ Contractors/ Sub Contractors</u>

- (1) The Bidder(s)/ Contractor(s) undertake(s) to demand from all sub contractors a commitment in conformity with this Integrity Pact, and to submit it to the Principal before contract signing.
- (2) The Principal will enter into agreement with identical conditions as this one with all Bidders, Contractors and Sub contractors.
- (3) The Principal will disqualify from the tender process all bidders who do not sign this Pact or violet its provisions.

#### Section 7 - Criminal charges against violating Bidders/ Contractors/ Sub Contractor

- (1) The Principal appoints competent and credible Independent External monitor for this Pact. The task of the Monitor is to review independently and objectively, whether and to what extent the parties comply with the obligations under this agreement.
- (2) The Monitor is not subject to instructions by the representatives of the parties and performs his functions neutrally and independently. He reports to the Executive Director, NABI.
- (3) The Bidder(s)/ Contractor(s) accepts that the monitor has the right to access without restriction to all Project documentation of the Principal including that provided by the Contractor. The contractor will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor is under contractual obligation to treat the information and documents of the Bidder(s) Contractor(s)/ sub Contractor(s) with confidentiality.
- (4) The Principal will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the Principal and the Contractor. The parties offer to the Monitor the option to participate in such meetings.
- (5) As soon as the Monitor notice, or believes to notice, a violation of this agreement, he will so inform the Management of the Principal and request the Management to discontinue or take corrective action, or to take other relevant action. The monitor

- can in this regard submit non-binding recommendations. Beyond this, the Monitor can in this regard to demand from the parties that they act in a specific manner, refrain from action or tolerate action.
- (6) The monitor will submit a written report to the Executive Director, NABI within 8 to 10 weeks from the date of reference or intimate to him by the Principal and should the occasion arise, submit proposals for correcting problematic situations.
- (7) Monitor shall be entitled to compensate on the same terms as being extended to/provide to Independent Directors on the NABI
- (8) If the Monitor has reported to the Executive Director, NABI as substantiated suspicion of an offence under relevant IPC/PC Act, and the Executive Director, NABI has not, within the reasonable time taken visible action to proceed against such offence or reported it to the Chief Vigilance Officer, the Monitor may also transmit this information directly to the Central Vigilance Commissioner.
- (9) The word 'Monitor' would include both singular and plural.

#### **Section 8 – Pact Duration**

This pact begins when both parties have legally signed it. It expires for the Contractor 10 months after the last payment under the contract, and for all other Bidders 6 months after the contract has been awarded.

If any claim is made/lodged during this time, the same shall be binding and continue to be valid despite the lapse of this pact as specified above, unless it is discharged/determined by Director, NABI.

#### Section 9 – Other provisions

- (1) This agreement is subject to Indian Law, Place of performance and jurisdiction is the Registered Office of the Principal, i.e. Chandigarh.
- (2) Changes and supplements as well as termination notices need to be made in writing. Side agreements have not been made.
- (3) If the Contractor is a partnership or consortium, this agreement must be signed by all partners or consortium members.
- (4) Should one or several provisions of this agreement turn out to be invalid, the remained of this agreement remains valid. In this case, the parties will strive to come to an agreement to their original intentions.
