Sealed Tenders in two parts [(i) Part-A: Techno-commercial bid & (ii) Part-B: Financial Bid)] are invited on behalf of the Executive Director, National Agri-Food Biotechnology, Mohali "For Hiring of Three (03) Indigo-CS (White) Cars for local/outstation travel" for a period of one year. The bids are invited from the prospective contractors/agencies holding a valid certificate issued by the competent authority of a PSU / Central / State Govt. / Pvt. Organization for satisfactory performance of a similar contract for hiring vehicles for atleast one year on the date of N.I.T. and having vehicles either owned or leased. Annual Estimated cost of the tender for all three cars is ₹.12,00,000/- (Rupees Twelve Lac only).
